#### **MEMORANDUM**

SUBJECT: INTRODUCTION OF PENSION-CUM-GRATUITY SCHEME TO PBC (NON-TRANSFEREE) EMPLOYEE

The case regarding the extension of pensionary benefits to PBC Employees (non-transferees) was under consideration for quite some time. The Federal Government has approved the Pension-cum-Gratuity Scheme for PBC Employees (non-transferees) with effect from 23.08.1982, knows as "Pakistan Broadcasting Corporation Employees (Pension-cum-Gratuity Scheme) Regulations, 1985". Notification (No.ROM-6/85) to this effect has been published in Part VI of the Gazette of Pakistan dated 17 July, 1985. A copy of the same is forwarded herewith for information and necessary action.

- 2. The contents of the aforesaid notification may please be brought to the notice of the following:
  - i) All existing employees (other than transferees from the former Department of Radio Pakistan) who joined PBC's regular service on or after 20.12.1972 (including the employees of this category who are on deputation/ secondment to other organisations within or outside the Country.
  - ii) All employees who had joined PBC's service on or after 20.12.1972 and have retired from service on or after 23.08.1982.
- Those who wish to retain their membership of the Contributory Provident Fund under regulation 4 of the aforesaid Regulations are required to exercise their option, in writing, in the form at Annexure-I (in triplicate) by 31<sup>st</sup> December, 1985. One copy of the option shall be pasted in the Service Book/Roll of the employee concerned and the other shall be sent to PBC Headquarters (Pension Branch) for record. The option once exercised shall be final. Any employees who does not exercise option, in writing by 31<sup>st</sup> December, 1985 shall automatically be governed by the Pakistan Broadcasting Corporation (Pension-cum-Gratuity Scheme) Regulations, 1985.
- 4. The employees mentioned in para2(2) who want to be governed by the aforesaid Pension-cum-Gratuity Scheme and who have already received final payment of their CP Fund dues from PBC will give their consent in writing, in the proforma at Annex-II for refund / adjustment of the Corporation's contributions towards their CO Fund alongwith interest thereon already drawn by them, towards their gratuity/ pension under the new scheme.

- 5. The employees who wish to be governed by the aforesaid Regulations may be required to submit Nomination for Death-cum Retirement Gratuity in the prescribed form 'A'/ 'B' (in triplicate by 30.09.1985. One copy of the same may please be sent to the Pension Branch at this Headquarters.
- 6. Receipt of this Memo may please be acknowledged.

## Notification Islamabad, July, 1985

No.ROM-6/85. In exercise of the powers conferred by section 22 of the Pakistan Broadcasting Corporation Act, 1973 (XXXII of 1973), the Board of Directors of the Pakistan Broadcasting Corporation, with the previous sanotion of the Federal Government, is pleased to make the following regulations namely:-

- 1. Short title, commencement and application.-(1). These regulations may be called the Pakistan Broadcasting Corporation Employees'(Pension-cum-Gratuity Scheme) Regulations, 1985.
  - 2. The Shall come into force at once.
- 3. They shall apply to all the employees of the Corporation who were in service on the 23<sup>rd</sup> August, 1982, or the joined or join service after that date hereinafter referred to as the employees, except the persons-
  - Transferred to the Corporation under section 12 of the Pakistan Broadcasting Corporation Act, 1973 (XXXII of 1973);
  - ii) Serving in the Corporation on deputation from the Federal Government or any other organisation; and
  - iii) Engaged on contract, or on daily wages or paid from the contingencies.
- 2. Application of Pension-cum-Gratuity Scheme, 1954 to employees of the Corporation-Subject to rule 4, the Pension-cum-Gratuity Scheme, 1954 as amended from time to time, as applicable to the Federal Government Servants and as in force before the commencement of these regulations and all amendments which may be made after such commencement shall, as far as practicable and with necessary adaptations, apply to the employees of the Corporation to whom these regulations apply.
