- 1. Short title, commencement and application.— (1) These regulations may be called the Pakistan Broadcasting Corporation Employees (Retrement from Service) Regulations, 1980.
 - (2) They shall come into force at once.
 - (3) They shall apply to all employees of the Corporation.
- 2. <u>Definitions.</u>— In these regulations, unless there is anything repugnant in the subject or context:—
 - (a) "employee' means a person transferred to the Corporation under sub-section (1) of section 12 of the Pakistan Broadcasting Corporation Act, 1973 (XXXII of 1973) and includes a person employed by the Corporation on or after the twentieth day of December, 1972, but does not include a person serving in the Corporation on deputation from the Federal Government or a Provincial Government; and
 - (b) "competent authority" means the appointing authority or a person duly authorised by the appointing authority in that behalf, not being a person lower in rank than the employee concerned.
- 3. Retirement. (1) An employee shall retire from service:
 - (i) on such date after he has completed twenty-five years of service qualifying for pension, gratuity or other retirement benefits as the competent authority may, in the public interest, direct; or
 - (ii) where no direction is given under clause (i), on the completion of the sixtieth year of his age.
- (2) An employee may, at any time after he has completed twenty-five years of service qualifying for pension, gratuity or other retirement benefits, apply for retirement from service by giving not less than three months' notice of his intention to retire.
